

An overview of our qualification

Whatever path your son or daughter chooses, they're at the start of an exciting journey. From exams and ethics to experience, we'll prepare them to enter the workplace ready to make a difference in today's fast-paced business world.

Foundation level

Our Foundation level qualifications provide an exceptional introduction to the finance sector and teaches a variety of essential skills and techniques. There are no formal qualifications to get started and for those at the very beginning of their journey, there are a range of roles they could undertake while studying, such as trainee bookkeeper, administrator and accountant.

Foundations in Professionalism

To gain any of the awards at the Foundation level and receive a certificate, your son or daughter must complete the online ethics module, Foundations in Professionalism. This interactive module is designed to help your son or daughter develop their understanding of what it means to act professionally and ethically at work.

How long will it take?

It's possible to complete all of the Foundation level exams within a year. However, all of the exams are available as on-demand computer-based assessments, so students are free to work at their own pace.

Applied Knowledge

From the accountant's role in business, to key capabilities such as financial and management accounting, our Applied Knowledge syllabus builds on your son or daughter's existing understanding of essential accounting techniques.

How long will it take?

The Applied Knowledge level can be completed in as little as 12 to 18 months. From here your son or daughter can go on to take the Applied Skills exams.

Applied Skills

The Applied Skills level gives your son or daughter a broad understanding of the practical finance capabilities required of a future strategic professional accountant.

The syllabus includes a wide range of subjects including corporate and business law, audit and assurance, taxation, financial management, and performance management.

With exams being updated annually, to ensure the ACCA Qualification is the most relevant available, they reflect the most recent changes to accounting standards, technology and employer demands.

How long will it take?

This Applied Skills level can be completed in as little as 12 to 18 months. From here your son or daughter can go on to take the Strategic Professional exams.

Strategic Professional

The Strategic Professional level is the final stage of the ACCA Qualification. Depending on their degree subject, your son or daughter may be exempt from the first nine exams and have a faster route to becoming an ACCA member. They'll learn the dynamic skills and strategic vision that all successful business and financial leaders need. It gives them the widest range of opportunities to specialise in areas that best suit their career ambitions. It could lead to senior positions, such as a financial manager, chief financial officer or a partner in a professional firm.

How long will it take?

By combining their studies and work experience, they could gain their ACCA Qualification and be a member in as little as three years.

What will it cost?

The cost of their qualification will depend upon a number of factors. There's a one-time registration fee that all students pay on registering with ACCA, which is followed by an annual subscription that keeps their student status open, allowing them to enter for exams and progress through the qualification.

For each exam they sit they'll have to pay an exam entry fee. If they're eligible for exemptions, they'll also be a fee payable to claim these. And, depending on their chosen method of study, they'll need to pay for any tuition delivered by a learning provider.



Twice the qualifications, without doubling workloads

If your son or daughter is not a graduate, the ACCA Qualification gives them the opportunity to achieve a BSc degree from a UK university – Oxford Brookes. Once they've completed a report as well as their ACCA exams they'll be awarded a degree without doubling their workload.

We offer four exam sessions

– March, June, September or
December – every year, so your

Where?

How?

Some of our exams are traditional paper exams but some are available as on-demand computer-based exams (CBEs). These can be sat at any time of the year, in any of our licensed CBE centres. Results are received instantly, and they can be re-taken as needed.
